PLEASE READ BELOW BEFORE PROCEEDING:					
Making a General Power of Attorney (GPOA) is an important action that has serious legal consequences. Your GPOA gives someone else the legal authority to act on your behalf—to do <i>anything</i> that you would be able to do. With a GPOA, your agent can (for example) rent or buy a house with your money, obtain a credit card in your name that you must repay, sell your car, sue someone for you, or remove all funds from your bank account. Your agent can legally bind you. While a GPOA can be very helpful, it can also be very dangerous. Don't give away more power than necessary. If you need someone to perform only specific tasks for you, then you don't need a GPOA. Get a <i>Special</i> (or Limited) Power of Attorney—one that will authorize your agent to perform only those specific tasks.
